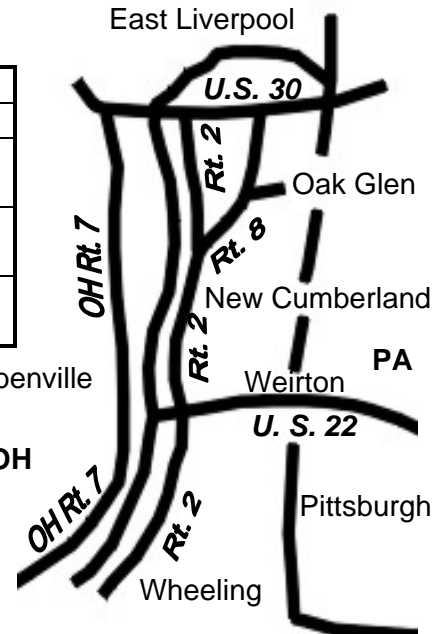


OAK GLEN OPEN WRESTLING TOURNAMENT
