**WVYWA BELT QUALIFYING TOURNAMENT**



**Fees:** \$35 single entry, or \$25 for entry for team submission for 10 or more wrestlers (must call).

Admissions: \$5.00 Adults, \$3.00 Students, under 5 free.

We accept cash, card, or check (**payable to BU Youth Wrestling**).

**Time:** Early Weigh ins for all: Friday December 13th 7-8 pm at BU Wrestling Facility (tan block building on right coming into BU-High School)

**Split youth tournament:** Weigh ins Saturday 12/14/24 @ High School for 4U, 5&6, 11&12 year olds from 7:00 am to 8:30 am and wrestling will begin 9-9:30 am.

Weigh ins for 7&8, 9&10, and Novice from 11:30 am-1 pm and wrestling will begin at approximately 1:30pm. Novice weigh in with their age groups. Novice division not eligible to qualify for belt.

**13-15 and Female Division:** Not eligible to qualify for belt. Weigh in Friday night - listed above, or Saturday morning 7:00 am to 8:30 am. Wrestling will begin 9-9:30 am. Female division will be madison bracketing with age divisions.

**Food:** Concession will be available all day. We accept cash, card, or check. Hospitality room for officials and coaches only.

**Matches:** Novice 7-10 one (1) three (3) minute period. 12-U age divisions will be 1-1-1 periods, scholastic rules apply. 13-15 rounds will be 1-1.5-1.5 periods. Girls Division: 12-U age divisions 1-1-1. Age division 13-17 will be 1-1.5-1.5. Double elimination unless in a round robin.

**Awards:** Individuals 1<sup>st</sup>-4<sup>th</sup> place receive awards. Team Placing 1<sup>st</sup>-3<sup>rd</sup>.
